#### INTRODUCTION:

The trustees present their annual report and the financial statements for the year ended 10<sup>th</sup> November 2023.

The trustees for the past year were Brian Davies – Treasurer, Terry Groom & Keith Cooper

#### CHARITABLE OBJECTIVES:

The trust administers the funds held for charitable purposes by the Western Front Association Suffolk Branch.

The aim of Suffolk Branch of the Western Front Association is to further interest in the period 1914-18 and to perpetuate the memory of all those who fought in that conflict.

To achieve its objects the Branch organises exhibitions, school visits, seminars and lectures.

The Branch will apply both to capital and income to such other charitable purposes as the club shall direct via duly constituted meetings.

#### **CHARITABLE ACTIVITIES:**

#### **Unrestricted funds**

Unrestricted funds of £2,814.55 were obtained from the activities shown on the income and expenditure account.

£2,632.60 costs were incurred for events, as shown on the income and expenditure account.

There was a small surplus of the year of £181.95 – this was due to the increase in meeting donations from £4 to £5 and a reduction in speaker fees. However the decline in the number of people attending meetings continues.

#### **Restricted funds**

No restricted funds were obtained or paid.

#### **Reserve and Reserve Policy**

There is no policy to maintain a certain level of unrestricted funds.
